# Overview

The School of Law and Economy of China is **a unique, one-year program** at the University of Warsaw. The two semesters long course consists of circa 130 hours and provides participants with **knowledge and skills** needed to have a blossoming career related to the Middle Kingdom.

The goal of the program is to equip the students with knowledge about the legal system, economy, culture and doing business with China. After finishing the course, the graduates shall be able to **run a business activity in China** by themselves, **understand Chinese investors** coming to CEE region, and be able to **work at a China desk** at any law firm.

In the academic year 2020/21, **all the lectures and workshops will be held online**. The experience gained during COVID-19 pandemic allowed us to plan an engaging online course led by **world-class lecturers**. Moreover, shifting into remote teaching allows us to plan classes independently from the COVID-19 pandemic in Poland and the University of Warsaw authorities' decisions on teaching in the upcoming semester.

## Mode of studies

**Duration:** One academic year (October 24 - June 12)

**Classes:** Saturdays from 10:00 AM to 4:00 PM (132 hours in total)

**Mode of teaching:** Lectures, case studies, workshops

**Language of instruction:** English

**ECTS points:** 12

## Graduation requirements

- We implement arrangements for alternative assessment to replace exams, and the final evaluation is based on student's activity during the classes. Students will be asked to prepare one-page memos once a month.
- During all of the online classes participants are asked to turn their cameras on.
- Two absences per semester are acceptable. An absence is regarded as not participating in an entire teaching session.
- Upon graduation, the students will receive a certificate issued by the University of Warsaw.



# Recruitment

## Admission requirements and the profile of candidates

The course is designed for current students of all years as well as university graduates. This well-tailored program is created for candidates coming in with legal, business, international relations and political science backgrounds.

Language skills: English (B2)

- ✓ The candidates are **not required** to provide a language certificate.
- ✓ Knowledge of Chinese is **not required** for the course.
- ✓ Legal knowledge is **not required** for the course. Legal background will be an additional advantage.
- ✓ Experience related to China is regarded as desired but not obligatory.

## Tuition fees

**Early bird fee for students:** 1 950 PLN / semester

**Early bird fee for professionals:** 2 900 PLN / semester

The early bird fee is valid until the **30th of September**. The School does not offer scholarships. Participants of the School might apply for an **interest-free loan supported by the Polish government**. Upon graduation students granted such loans might be subjected to a 25% discount. 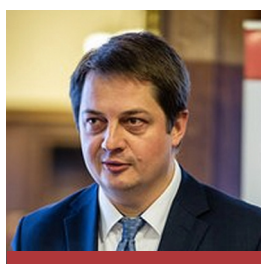
## Summer semester

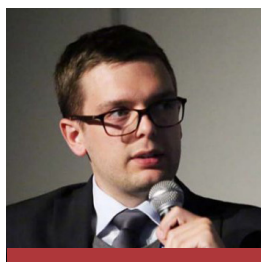
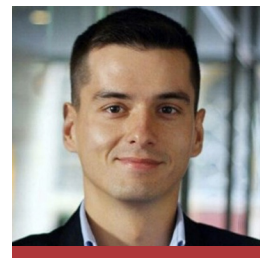


## **PROF. DOMINIK MIERZEJEWSKI** **CENTER FOR ASIAN AFFAIRS**

Chair at Center for Asian Affairs (University based think-tank), professor at the Department of Asian Studies at the Faculty of International and Political Studies, studied at the Shanghai International Studies University (1999-2000, 2003-2004), visiting professor in the Chinese Academy of Social Science granted by the Polish Foundation for Science (2010-2011), member of: European International Studies Association, European Association for Chinese Studies (board member 2008-2014) and vice editor in chief of "Azja-Pacyfik" (yearbook) and "Journal of Contemporary Eastern Asia" (Austria/South Korea) and "Sinologia Hispanica". His research focuses on China's political development, rhetoric of Chinese foreign policy and local governments involvement in China's foreign policy. He publishes two monographs, and dozens of articles published e.g. in Singapore, United Kingdom and the United States.

Tamas Matura is the Founder of the Central and Eastern European Center for Asian Studies. He has been working on China for a decade, started his career at the Hungarian Institute of International Affairs. 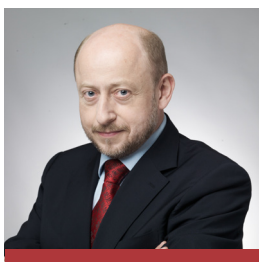


**DR DARREN CHONG**

**POLISH-CHINESE EDUCATION FOUNDATION**

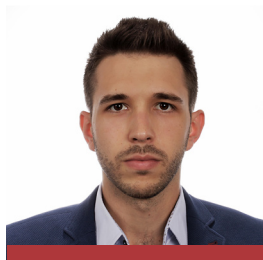

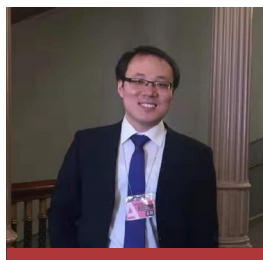


**GRZEGORZ STEC**

**EMBASSY OF THE UNITED KINGDOM IN WARSAW**

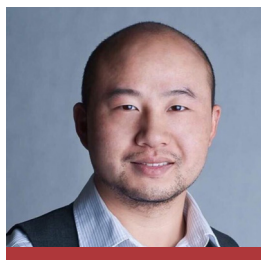

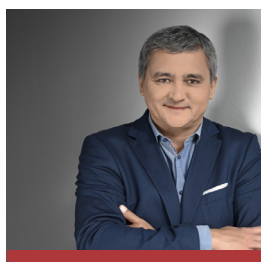


**MEI GUANGGUI**

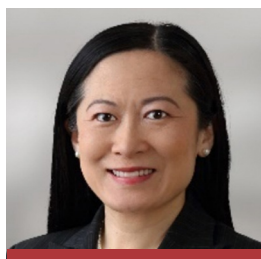
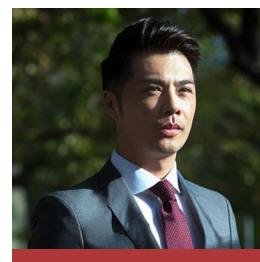


**DR AGNIESZKA ŁUSZPAK-ZAJĄC**
