

ELIZABETH M. ZECHENTER, Ph.D., J.D.

SOCIAL SCIENTIST, INTERNATIONAL ATTORNEY and a LEGAL SCHOLAR

Dr. Elizabeth M. Zechenter is a US-trained international attorney, social scientist, academic researcher, and public speaker holding J.D. (international law), M.A. (Latin American history), and Ph.D. (archaeology/evolutionary anthropology). She is currently a visiting professor at the Faculty of Artes Liberals at the University of Warsaw.

She was born in Poland but educated mostly in the U.S. She began her education at the Jagiellonian University in Krakow under Professor Godlowski. She continued her studies in the US at Emory University and at UCLA. She worked on the evolutionary issues and economic foundations of social complexity in the late preceramic Peru and directed a large multi-disciplinary research project (Proyecto PARAISO) in the Supe valley of the Central Peruvian coast. She also participated in other research projects including excavations of the Middle Intermediate Period settlements in the Montaro Valley of Central Peruvian Highlands as well as in the excavations of Inca habitation in that area.

After obtaining J.D., she worked on international public and private law issues at two major US law firms (Hogan and Lovells and Morgan and Lewis) until joining a large multinational corporation where she served as an Assistant General Counsel responsible for international legal operations, research and development in Asia, Latin America, and finally worldwide for the GlaxoSmithKline.

She combines both law and social science and works on the issues of international human rights and the rule of law. She is the author of several articles (both scientific and popular ones) and a frequent public speaker. Dr. Zechenter has taught international law and human rights law courses at the Georgetown University Law Center as well as social science courses at UCLA, University of Pennsylvania, Temple and Rutgers Universities.

She has served as an associate editor of the *International Law Journal of Georgetown University Law Center* and worked as a summer clerk to Judge Sloviter, Chief Judge, the U.S. Court of Appeals for the Third Circuit.

Her current research interests include the theoretical foundation of modern human rights laws and their applicability in a diverse world, especially in cases of culturally disadvantaged and discriminated groups such as women, minorities, and indigenous populations. She is currently involved in several projects involving violations of human rights, international law projects aimed at supporting minority populations,

women, and other vulnerable populations, as well as projects aiming at supporting free elections, independence of judges, and the rule of law.

Dr. Zechenter has held several elected offices, among them, chair of the International Human Committee of the Philadelphia Bar, chair of the Subcommittee on Human Rights of Indigenous Peoples for the Human Rights Committee of the American Bar Association (ABA) and was a member of the International Human Rights Steering Committee for Section of International Law and Practice of the ABA. She was a member of the Working Group on Law and Anthropology of the American Anthropological Association's Commission for Human Rights. She was also a presidential appointee to the Advisory Board for the Center e of Human Rights of the ABA.

Dr. Zechenter currently serves as the chair of the Women's Interest Network (WIN) and the chair of the International Human Rights Committee of the American Bar Association; she is the president of the Jagiellonian Law Society and the board member and secretary of the Philadelphia Chapter of the Kosciuszko Foundation as well as Kosciuszko's Foundation National Advisory Council.

She also serves on the Ukrainian Task Force of the New York Bar Association (NYSBA) and has published several articles and has been speaking on the issues concerning the war in Ukraine as well as organized two webinars on the crime of genocide as related to Ukraine with outstanding intentional faculty and keynoted by the US Ambassador Stephen Rapp.

She has been active in various pro bono projects, including:

- a) Representing a young Ethiopian woman from the minority Oromo ethic group who was raped and harassed by the local government officials from the dominant ethnic group but denied US political asylum. On appeal, Dr Zechenter won asylum for that client even though rape and gender-based violence are hard to prove and afforded lesser levels of legal protections than other forms of political violence. Received the **Human Rights GURU Award** from Hogan & Hartson for that work.
- b) As Chair of the Working Group on Law and Social Science for the Commission of Human Rights of the American Anthropological Association, she advised the Commission on legal and social issues facing indigenous people in Latin America, and especially Amazonian tribes.
- c) Representing pro bono clients in various social security matters in the US while at Hogan and Hartson: advised Nigerian clients in their asylum case; provided legal advice to the Guardian Ad Litem to a minor Jamaican girl who applied for US asylum after years of sexual and other abuses suffered when in custody of the US citizens. Received "I Met the Challenge Award" for that work.
- d) Advising Committee for Human Rights on the El Salvador Amnesty Law and its compatibility with the international treaty obligations. Drafted a position paper on the validity of that law for the use by the Inter-American Court for the Organization of American States
- e) Providing pro bono assistance leading to the creation of an American tax-exempt non-profit corporation needed to solicit funds for a *Children Hospital in Warsaw*, Poland, and
- f) Serving as an *Election Observer for the OSCE-ODIHR Parliamentary* Elections Observation Mission in Ukraine, traveled as a member of the US Department of State delegation to Ukraine to observe elections in the Vinnica region, 1998.

For her work, Dr Zechenter was elected **Fellow, American Bar Foundation** ("The Fellows of the American Bar Foundation comprise a global honorary society of attorneys, judges, law faculty, and legal scholars whose public and private careers have demonstrated outstanding dedication to the highest principles of the legal profession and to the welfare of their communities. Membership in the Fellows is limited to one percent of lawyers licensed to practice in each jurisdiction. Fellows are recommended by their peers and elected by the Board of the American Bar Foundation").

She was also awarded **Lifetime Achievement Award** for the work on human rights of women, at the Third Annual International Law Conference on the Status of Women held in the lead-up to the 66th Regular Session of the UN Commission on the Status of Women, and co-sponsored by the New York City Bar, American Bar Association, and New York State Bar Association. Awarded the Lifetime Achievement Award for advocacy and humanitarian work on behalf of the human rights of women and various disadvantaged populations.

Due to Dr. Zechenter's contributions to *Ukraine Task Force* and her providing monthly reports and insights into Polish society and the mass social response to the influx of Ukraine refugees, the Secretary of the Ukraine Task Force organized a successful fundraiser, not for Ukraine but for Polish NGOs helping Ukraine. This is how she described what happened:

"Because of Elizabeth, I felt compelled to individually sponsor and finance a Fundraiser in September 2022 for both Poland and Ukraine utilizing the International Law Firm of Paul Weiss Rifkind Wharton & Garrison as a location and The United Jewish Federation of Northeastern New York, raising monies in the five digit sums. Many people have been hosting various Ukrainian fundraisers, but it is the people of Poland, not the government, who were the ones opening their homes, that are the unsung heroes. It was Elizabeth, the unsung hero, whom I credit, that taught me that the world needed to know Poland's long history of generosity that needed recognition. The Fundraiser is still raising money as a result of her."
