Vakhtangi Giorgadze is Counsel & Team Lead at the Singapore International Arbitration Centre. He is a qualified lawyer, admitted to the bar in Georgia, and a Singapore International Mediation Institute (SIMI) accredited mediator. Prior to joining SIAC, Vakho was a research associate at the Singapore International Dispute Resolution Academy where he published and contributed to the publication of peer-reviewed papers, reports, and books. In his role, he co-authored the 2nd edition of the book "The Singapore Convention on Mediation – A Commentary".

Vakho's experience includes working for the legal affairs division of the World Trade Organization where he advised a panel on the resolution of an international trade dispute between two states. He also worked for a tier-one law firm in Georgia and for the Ministry of Justice of Georgia where he contributed to the implementation of the Association Agreement between the European Union and Georgia in Georgian legislation. Maria is actively involved in initiatives supporting the legal education of young lawyers, including as a Lead Mentor in the Women in Law Foundation's mentoring programme for young female lawyers, and she coordinated the Lewiatan Arbitration Moot Court—the largest moot court competition in Poland for bar trainees—from 2012 to 2022. She is the author of publications on procedural law and arbitration, a speaker at dispute resolution conferences, a lecturer at the Warsaw Bar Association of Attorneys-at-Law (OIRP Warsaw) and the University of Warsaw, and the creator of a social media profile dedicated to corporate disputes. In 2024, she was included in the "25 Women in Business" list by Forbes Women and the Women in Law Foundation, and she cooperates pro bono with the "po Drugie" Foundation and the "Jesteśmy Nadzieją" Association.



## 2st discussion round:

# How to Prepare a Company for a Dispute Before It Arises?

### Speaker:

**Dr Barbara Skardzińska** is a legal counsel with over 15 years of experience in corporate law, M&A, commercial and financial transactions, as well as international arbitration and dispute resolution. She currently serves as Chair of the Supervisory Board of Trakcja S.A. and General Counsel at PKP Polskie Linie Kolejowe S.A. (Polish Railway Lines), leading a legal department that supports the company's headquarters and 26 regional units across Poland. Over the past two years, her team managed the largest dispute resolution activity in the company's history, including 27 settlements valued at approximately PLN 900 million (~€190 million) in 2025. Previously, she worked in top-tier international and national law firms, advising on complex corporate, M&A, banking, and financial transactions, including cross-border and infrastructure projects. Alongside her professional practice, Dr Skardzińska maintains an active academic profile. She has studied or conducted research at over 25 scientific centres worldwide, including Stanford University, University of Florida Levin College of Law, Freie Universität Berlin, The Hague Academy of International Law, and the International Arbitration Academy in Paris. During her studies, she won 1st Prize in the International Commercial Arbitration Essay Competition organised by Rzeczpospolita and K&L Gates. She has also been involved in research initiatives funded by the Polish National Science Centre and the Polish Space Agency. Outside of her professional work, she mentors young female lawyers and law students and co-hosts the podcast Zawód Prawniczka, dedicated to career development, leadership, and work-life balance. Her achievements have been recognised in the Top 25 Women Lawyers in Business (Forbes Women), Top 50 Lawyers to Follow on LinkedIn, and the Rising Stars Lawyers ranking by Dziennik Gazeta Prawna, where she was described as a "lawyer hard to classify."
